I: THE CONVENOR'S EDITORIAL

THE END OF THE SPLIT-SCREEN LIFE: WHY WE ARE HERE

To my fellow Waymakers,

As I sit in my office in Sydney, looking out at the global landscape of the marketplace, I am struck by a singular realisation: The world does not need more "employees" who happen to be Christians. It needs Marketplace Ministers who happen to be professionals.

For nearly three decades, I have navigated the worlds of public health, epidemiology, and high-level research, Christian ministry, and community service. I have walked the halls of government and academia, stood on the frontlines of emergency response deployments, and sat in the quiet rooms of prayer. For a long time, like many of you, I felt the pressure to live a "split-screen life"—to be the highly decorated professional from 9 to 5, the successful leader in my field, and then serve at church after hours and on the weekend.

But God reminded me that He has a different architecture in mind.

THE BIRTH OF A MOVEMENT

The Marketplace Missions Movement was born in 2023 out of a refusal to accept the false sacred-secular divide and a realisation that I was called to fulfil a divine Kingdom mandate to lead a movement in the workplace. I was reminded that my career wasn't just a vehicle for a paycheck or professional accolades; it was my primary mission field. My expertise in public health—frontline emergency response, disease surveillance, programme evaluation—wasn't separate from my faith. It was the platform God gave me to exercise Kingdom authority wherever I went.

This became evident through every previous assignment: emergency preparedness and response, advisory roles, workplace projects, strategic evaluations. Each one was not just a job—it was a Kingdom deployment.

And as I reflected on my journey at the end of 2025, I had a revelation of what God has been doing through me all along:

"I don't build empires; I convene movements."

Empire-building is about gatekeeping access and centralising power. Movement-building is about activating others to fulfil their mandate. Empire-builders create followers. Movement conveners raise up leaders. And that distinction changed everything.

WHY WAYMAKERS ALLIANCE EXISTS

That is why I created the Waymakers Alliance. I wanted to create a space for the "Professional Believer"—the leader who is mid-to-late career and senses that there is a "Next Chapter" that requires more than just a job search tactic or adding more accolades to their credentials.

You are here because you are ready to move from survival mode to stewardship mode.

II: THE STRATEGIC FRAMEWORK:

THE THREE PILLAR FRAMEWORK FOR MARKETPLACE MINISTRY

INTRODUCTION

The marketplace is not neutral territory—it is a spiritual battleground. Every boardroom, hospital ward, classroom, courtroom, tech company, and government office is contested space.

Most believers spend 40-60 hours per week in the marketplace but have no framework for understanding their spiritual role there. They know how to pray at church and worship on Sunday.

But Monday through Friday? They're navigating spiritual dynamics without a map. That ends today.

The Three Strategic Kingdom Mandates—Vigilance, Alignment, Victory—are not motivational slogans. They are tactical intelligence for marketplace deployment. They are your operational framework for exercising Kingdom authority in secular spaces.

These three mandates are non-negotiable for marketplace ministers. You cannot operate effectively without all three.

MANDATE 1: VIGILANCE - THE GUARDED GATE

BIBLICAL FOUNDATION

"We prayed to our God and posted a guard day and night to meet this threat." (Nehemiah 4:9)

"For our struggle is not against flesh and blood, but against the rulers, against the authorities, against the powers of this dark world and against the spiritual forces of evil in the heavenly realms." (Ephesians 6:12)

WHAT IS VIGILANCE?

Vigilance is spiritual warfare in the workplace—the active practice of guarding spiritual gates, discerning atmospheres, and protecting your sphere from spiritual attack.

Most workplace dysfunction is not merely human—it is spiritual. That toxic boss? That culture of fear? That sabotage pattern? You're dealing with spiritual opposition. Vigilance means you see what's really happening and respond with Kingdom authority.

THE DISCERNMENT TEST

Not every workplace challenge is spiritual warfare. How do you tell the difference?

Ask:

1. Is this behavior consistent with the person's character? (If no → possible spiritual component)
2. Does prayer shift the atmosphere? (If yes → spiritual)
3. Is Kingdom assignment being blocked? (If yes → likely spiritual warfare)

YOUR VIGILANCE PROTOCOL

Daily: Pray over your workspace. Ask God: "What spiritual atmosphere is present today?"

Weekly: Spiritually survey your sphere. Intercede for 5-10 coworkers by name.

Monthly: Break ungodly agreements. Set spiritual boundaries. Evaluate: Has the atmosphere shifted?



REAL-WORLD EXAMPLE

Sarah, a marketing director in the USA, noticed her team was constantly overwhelmed despite manageable workloads. Burnout was rampant. Morale was non-existent. She discerned: This is a spirit of anxiety.

Sarah began praying daily for peace and Kingdom culture. She didn't preach—she just stood as a gatekeeper. Within 4 weeks, the atmosphere shifted. Team morale improved. Productivity increased. Sarah didn't preach. She GUARDED the gate.

MANDATE 2: ALIGNMENT - PROPHETIC PACING

BIBLICAL FOUNDATION

"Trust in the Lord with all your heart and lean not on your own understanding; in all your ways submit to him, and he will make your paths straight." (Proverbs 3:5-6)

"Very truly I tell you, the Son can do nothing by himself; he can do only what he sees his Father doing..." (John 5:19)

WHAT IS ALIGNMENT?

Alignment is moving at the speed of obedience—hearing God's voice for career decisions, discerning divine opportunities vs. human distractions, and knowing when to move and when to wait.

The marketplace says: "Faster is better. First-mover advantage. Strike while the iron is hot."

The Kingdom says: "Obedience is better than speed. Divine timing is better than first-mover advantage. Waiting on God is strategic positioning."

THE ALIGNMENT TEST

Before Accepting Any Opportunity,

Ask:

1. Do I have peace? (Not just excitement—PEACE)
2. Does this align with my Kingdom assignment? (Not just my ambition)
3. What is God saying when I ask Him directly?
4. Is this the right timing? (Right opportunity, wrong timing = wrong decision)
5. Am I being led by faith or fear?

If you don't have clarity: WAIT. God's opportunities don't have expiration dates.

WHY PROPHETIC PACING IS A COMPETITIVE ADVANTAGE

1. You avoid costly mistakes. Human opportunity often leads to dead ends. Divine opportunity leads to breakthrough.
2. You conserve energy. Chasing every door drains you. Walking through God's doors sustains you.
3. You build on solid ground. Hasty decisions create shaky foundations. Patient obedience creates Kingdom infrastructure.
4. You receive supernatural favor. When God opens a door, NO ONE can shut it (Isaiah 22:22).

YOUR VIGILANCE PROTOCOL

Daily: Pray over your workspace. Ask God: "What spiritual atmosphere is present today?"

Weekly: Spiritually survey your sphere. Intercede for 5-10 coworkers by name.

Monthly: Break ungodly agreements. Set spiritual boundaries. Evaluate: Has the atmosphere shifted?

REAL-WORLD EXAMPLE

James, a software engineer in the UK, was offered a director-level promotion with a 40% salary increase. Everyone told him he'd be crazy to turn it down.

But when James prayed, he had zero peace. He turned it down.

Three months later, James was headhunted for a role at a Kingdom-minded tech company where he mentors younger developers AND uses his skills for global Kingdom impact.

The salary? Better than the promotion he turned down.

ALIGNMENT saved James from a golden cage.

MANDATE 3: VICTORY - THE DECREE

BIBLICAL FOUNDATION

"You will also decree a thing, and it will be established for you; so light will shine on your ways." (Job 22:28, NKJV)

"Truly I tell you, whoever says to this mountain, 'Go, throw yourself into the sea,' and does not doubt in their heart but believes that what they say will happen, it will be done for them." (Mark 11:23)

WHAT IS VICTORY?

Victory is prophetic declaration and decreeing Kingdom outcomes—operating in spiritual authority, calling forth God's will in your sphere, and seeing breakthrough manifest.

This is not positive thinking. This is not "name it, claim it" theology. This is Kingdom authority.

When you decree, you are not manipulating God. You are aligning your words with what Heaven has already spoken and releasing that reality into the natural realm.

WHAT DECREEING IS AND IS NOT

What Decreeing Is NOT:

- ✗ Positive affirmations ("I'm successful, I'm wealthy")
- ✗ Manipulating God to do what YOU want ✗
- Speaking from human ambition

What Decreeing IS:

- ✓ Aligning your words with God's will
- ✓ Declaring what Heaven has already spoken
- ✓ Releasing Kingdom authority into the natural realm
- ✓ Prophetic intercession that shifts atmospheres

The Formula: "I decree [what God has said] over [your professional sphere] in Jesus' name."

YOUR VICTORY PROTOCOL

Daily Decree (Before Starting Work):

"I decree that I am a marketplace minister with Kingdom authority. My work today will bring glory to God. Divine appointments are ordained. Favor surrounds me. Breakthrough manifests. I operate in wisdom, discernment, and prophetic insight. Kingdom outcomes are established through my hands today. In Jesus' name, Amen."

Sample Decrees:

- *"I decree Kingdom culture in this workplace"*
- *"I decree that this project will bring glory to God and serve people well"*
- *"I decree that ungodly agendas in this organisation are exposed and dismantled"*
- *"I decree breakthrough in areas where I've been believing God"*



REAL-WORLD EXAMPLE

Amara, a real estate agent in Nigeria, had a property deal fall apart—financing failed, buyers backed out. She was ready to walk away.

Then she learned about VICTORY. She stood in her office and decreed: "This deal is not dead. God is making a way."

Within 48 hours, a new buyer appeared with cash. The deal closed in record time.

Amara didn't just hope. She DECREED. And Heaven responded.

CONCLUSION: THE THREE PILLARS

These three mandates—VIGILANCE, ALIGNMENT, VICTORY—are your foundation.

You are not just an employee, entrepreneur, or professional. You are a MINISTER with Kingdom authority in the marketplace. Every monthly Waymakers call dives deeper into one of these mandates. Every Intelligence Report expands your strategic intelligence.

This is tactical. This is biblical. This is immediately actionable.

III: FOUNDING MEMBER SPOTLIGHT

"From Isolation to Kingdom Impact: A Counsellor's Marketplace Ministry Journey"

I am an educator and a licensed Associate Counselling Psychologist, currently serving as a Senior University Counsellor. Navigating this profession while honoring my faith presents unique challenges. In the mental health field—especially within an academic setting—ethics demand that faith stays separate from clinical practice—unlike Christian counselling, where it's central. Clients March invite their faith into our sessions, but only at their initiative and I steward those sacred moments. Conversely, others who identify as Christians prefer to keep their faith entirely out of therapy. This is unlike the bold sanctuary of Christian counselling, where faith is central. Yet in this tension, my spirit burned with one core question: *Is this my ministry assignment from God?*

It shaped my evangelism too—my aim as a senior counsellor was always to foster a welcoming space for staff and students to engage openly in therapy and encounter healing without walls.

In a season of prayer, seeking God's purpose for my role, that I learned about Dreambuilder through my best friend. I had no initial plans to join, but as I prayed for ways to align my spiritual calling with my duties, Stephanie Fletcher-Lartey's name came clearly to my spirit. I reached out without hesitation.

Dreambuilder propelled me into the Waymakers Alliance—a divine pivot that shattered every doubt. *Yes—my practice is unmistakably ministry!* My desk transformed into a holy altar; my clients, a thriving mission field. God confirmed: This is your assignment, Waymaker!

This shift was reinforced by powerful encounters:

- A client gripped by clinical depression and suicidal ideation was referred for urgent sessions. Dragged unwillingly to church with his sister, he found himself reflecting on what we had discussed. During worship, he spoke aloud against the negative voices tormenting him, calling on God for help. He felt a weight lifted and later realised much of his depression stemmed from spiritual oppression—and that real freedom was possible.
- At a retiree function where I spoke about forgiveness—prompted spontaneously by the Holy Spirit—an attendee was moved to tears. She shared afterward that my words reminded her of a past wound she had harbored against a colleague. She confessed that she had left her job withholding forgiveness but now felt released to let go of the hurt.
- A young male adult client carrying a deep “father wound” struggled to even mention his father. Yet, in therapy, when he acknowledged the pain dating back to his early childhood, he wept openly. He expressed a newfound desire to repair their relationship and now communicates freely with his father.

While mental health challenges are undoubtedly supported by scientific and empirical evidence, one cannot ignore the spiritual warfare beneath these issues. Many psychological storms reflect spiritual battles, as seen in biblical figures like Elijah and Saul.

How To Incorporate Prayer In My Session?

So, how do I incorporate prayer in my sessions? Prayer is offered as a covert weapon or bold declaration when welcomed by the client. Discerning the difference between circumstantial psychological issues and spiritual oppression is critical. As God's gatekeeper, I remain vigilant about the nature of the battle we face—psychological, spiritual, or both—warring against and protecting clients from toxic shame, lies, deception, and hopelessness, declaring victory in Jesus name.

Top 3 Kingdom Truths for Helping Professionals

- **Your empathy is a spiritual gift, not just a skill.** When you hold space for someone's pain, you're reflecting the heart of God.
- **Mental health and spiritual health are interconnected.** You don't have to choose between psychology and prayer—you can steward both.
- **You are a gatekeeper.** Every client you serve is a soul God has placed in your care. Guard them fiercely.

2026: THE DIVINE HANDOVER - WHY THIS YEAR MATTERS

THE DIVINE HANDOVER: THE JOSEPH ANOINTING

Prophetic ministers like Joseph Z and others are speaking of a "divine handover" of influence. They suggest that God is removing "unfaithful stewards" from positions of power and handing the "keys of the marketplace" to a new breed of uncompromised believers.

The Biblical Model: Joseph and Daniel

Both Joseph (Genesis 41) and Daniel (Daniel 6) served in high-level "pagan" governments and marketplaces **without losing their Kingdom identity**. In fact, their faith made them **indispensable**.

- **Joseph** rose to Prime Minister of Egypt during a global economic crisis. His Kingdom wisdom saved nations.
- **Daniel** served multiple kings in Babylon with such excellence that his only "fault" was his devotion to God (Daniel 6:4-5).

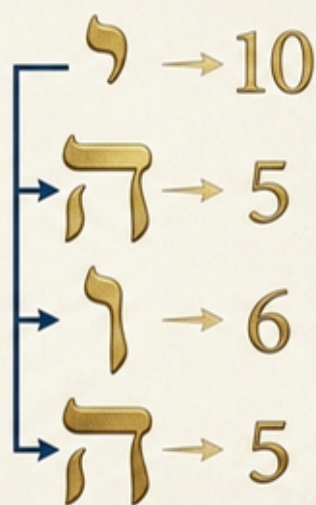
The Goal for 2026 : To provide divine solutions to economic and social problems, making the wisdom of God indispensable to the world.

This is not about Christians "taking over" culture through force or manipulation. This is about believers operating with such **excellence, integrity, and Kingdom wisdom that secular leaders seek them out for counsel**.

THE MESSIANIC PERSPECTIVE: THE POWER OF THE NAME

Messianic leaders like Rabbi Jason Sobel have highlighted the significance of 2026 through **Hebrew Gematria** (the numerical value of Hebrew letters). In Hebrew, the Divine Name of God—YHWH (יהוה)—has a numerical value of 26.

Gematria of YHWH



Total = 26

The Prophetic Interpretation:

2026 is a year to **"carry the Name"** into the marketplace. It is about identity—knowing that your authority at work doesn't come from your title, job description, or professional credentials.

Your authority comes from the Covenant Name you represent.

When you walk into your workplace, you don't just carry your resume. You carry **YHWH—the Name above every name**.

There is also a heavy emphasis on **"One New Man"** (Ephesians 2:15)—Jew and Gentile together—standing as a united front in professional spheres. The Messianic movement is declaring that 2026 is a year of alignment between Jewish and Gentile believers in the marketplace.

SCRIPTURAL GROUNDING: THE MARKETPLACE MANDATE

This "marketplace mandate" is not new theology. It is rooted in Scripture:

The Great Commission	Matthew 28:19	Discipling "nations" (ethnos)—spheres of influence, not just individuals

YOUR FIRST 30 DAYS AS A WAYMAKER: A PRACTICAL ACTIVATION GUIDE

You've joined Waymakers Alliance. You've received the intelligence. Now what?

This 30-day activation guide helps you shift from "professional" to "marketplace minister."

Small daily practices create massive Kingdom impact. This is not theory. This is tactical.

WEEK 1: VIGILANCE (Days 1-7)

DAY 1: Consecrate Your Workspace

- Pray over your desk, office, or workspace
- Anoint it with oil (if possible) or declare it holy ground

Ask God to use this space for Kingdom purposes

DAY 2: Discern the Atmosphere

- Walk through your workplace and ask: "What spiritual atmosphere is here?"
- Notice: Peace? Stress? Competition? Fear? Control?
- Write down what you sense

DAY 3: Identify Spiritual Gates

- Where are the entry points for ungodly influence in your workplace?
- Examples: Gossip, unethical practices, toxic leadership, fear-based culture
- These are gates you must guard

DAY 4: Pray for Your Coworkers

- Create a prayer list of 5-10 coworkers by name
- Pray for them daily (silently or aloud)
- Don't preach—just intercede

DAY 5: Break Ungodly Agreements

- Ask God: "Have I made any ungodly agreements in my professional sphere?"
- Examples: "I have to compromise my values to succeed," "I'll never advance because of [excuse]"
- Repent and renounce those agreements

DAY 6: Set Spiritual Boundaries

- Where do you need stronger boundaries at work?
- What will you no longer tolerate? What will you guard?
- Declare those boundaries prophetically

DAY 7: Reflection

- Journal: "How has my awareness of spiritual vigilance shifted this week?"

WEEK 2: ALIGNMENT (Days 8-14)

DAY 8: Ask God About Your Current Role

- "God, is this job/position still Your assignment for me?"
- Listen. Don't assume. Wait for clarity.

DAY 9: Identify Your Kingdom Assignment

- "God, WHY am I in this specific role, company, industry?"
- Your assignment might not be the job title—it might be a specific person, project, or transformation

DAY 10: Audit Your Opportunities

- List every opportunity currently on your plate
- Ask of each: "Is this from God or from human ambition?"
- Eliminate, delegate, or decline anything that's not divinely aligned

DAY 11: Practice Prophetic Pacing

- Where is God asking you to WAIT before moving?
- Where is God asking you to MOVE NOW?
- Obedience over opportunity

DAY 12: Hear God's Voice for One Decision

- Pick one decision you're facing at work (big or small)
- Spend 20 minutes in silence asking God's direction
- Write down what you hear

DAY 13: Obey Immediately

- Whatever God spoke on Day 12—obey it TODAY
- Even if it's scary, inconvenient, or doesn't make sense
- Speed of obedience = speed of breakthrough

DAY 14: Reflection

- Journal: "What shifted when I moved in alignment with God this week?"

WEEK 3: VICTORY (Days 15-21)

DAY 15: Decree Over Your Workplace

- Stand (physically or spiritually) and decree Kingdom outcomes
- Example: "I decree peace, productivity, and Kingdom culture in this workplace"

DAY 16: Declare Your Professional Identity

- "I am not just a [job title]. I am a marketplace minister."
- Say it aloud. Believe it.

DAY 17: Prophecy Over a Project

- Pick one project, client, or task
- Declare God's will over it: "This project will bring glory to God and serve people well"

DAY 18: Break Limitation

- What limiting belief has held you back professionally?
- Decree the opposite: "I am not limited by [excuse]. God is opening doors for me."

DAY 19: Call Forth Breakthrough

- What breakthrough are you believing God for?
- Decree it: "I call forth [specific breakthrough] in Jesus' name"

DAY 20: Stand in Authority

- Where do you need to operate in greater spiritual authority at work?
- Ask God: "What authority have You given me that I'm not using?"

DAY 21: Reflection

- Journal: "What victories (big or small) have I seen this week?"

WEEK 4: INTEGRATION (Days 22-30)

DAY 22: Integrate Vigilance Daily

- Set a daily calendar reminder: "Pray over workspace + discern atmosphere before starting work"

DAY 26: Document Your Journey

- Create a "Marketplace Ministry Journal"—record spiritual shifts, answered prayers, Kingdom wins (you'll forget if you don't write it down!)

DAY 23: Integrate Alignment Weekly

- Schedule a recurring weekly "Alignment Check": Review decisions made this week—were they led by God or driven by fear/ambition?

DAY 27: Identify Your Accountability

- Who will you share your marketplace ministry journey with? A mentor? A fellow Waymaker? Schedule your first check-in call

DAY 24: Integrate Victory Monthly

- Create a monthly "Decree Day": First Monday of every month, decree Kingdom outcomes over your industry/company/projects

DAY 28: Audit Your Boundaries

- Review: What spiritual boundaries have you set? Are you maintaining them? Where do you need to strengthen your "No"?

DAY 25: Build Your Prayer List

- Finalise your list of 5-10 coworkers you'll intercede for consistently—write their names, pray for each today

DAY 29: Plan Your Next 30 Days

- Based on what you've learned, what ONE mandate will you focus on deepening next month? (Vigilance, Alignment, or Victory)

Day 30! 📅 🌅 MORNING

REFLECTION (10-15 minutes):

Look Back at Day 1:

- What was your mindset about work 30 days ago?
- How did you see your professional role then vs. now?

What has shifted in your understanding of marketplace ministry?

Answer These Questions:

1. What surprised you most during these 30 days?
 - A spiritual shift you didn't expect?
 - A prayer answered?
 - A new awareness of God's presence at work?
2. What victories have you seen (big or small)? Atmosphere shifts in your workplace?
 - Divine appointments or favor?
 - Breakthrough in a specific project or relationship?
 - Greater boldness or peace?
3. What resistance did you encounter?
 - Spiritual opposition?
 - Internal doubts?
 - External challenges?
 - How did you overcome it (or what did you learn)?
4. How have YOU changed in 30 days?
 - Your prayer life at work?
 - Your discernment of spiritual dynamics?
 - Your confidence operating as a marketplace minister?
 - Your understanding of your Kingdom assignment?

CELEBRATION ACTIONS:

1. Write Your Testimony (100-200 words)

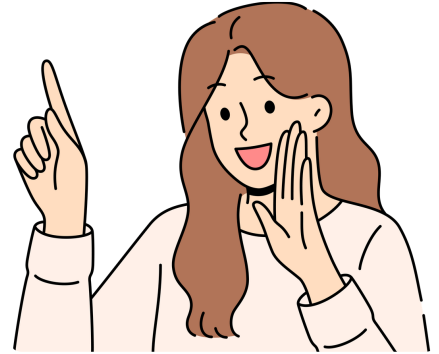

SECTION VI: WAYMAKERS Q&A

YOUR MARKETPLACE MINISTRY QUESTIONS ANSWERED

Q1: "Can I be a marketplace minister if I'm not in a 'Christian' job?"

A: ABSOLUTELY. In fact, that's the POINT. Marketplace ministry happens in secular spaces—corporate offices, hospitals, schools, tech companies, government agencies, trades, arts. Your "secular" job is your sacred assignment. God placed you there strategically.

Q2: "How do I integrate faith at work without being 'that annoying Christian'?"

A: Marketplace ministry is not about preaching at coworkers or slapping Bible verses on everything. It's about PRESENCE, not performance. Your Kingdom impact happens through: integrity in your work, how you treat people, the atmosphere you carry, silent intercession for colleagues, speaking truth when prompted by the Spirit, and letting your life be a sermon. You don't have to announce you're a Christian—people will know by your fruit.

Q3: "What if my workplace is hostile to faith?"

A: That's EXACTLY where you're needed most. Hostile environments need gatekeepers. Your role is to: pray for the atmosphere to shift, guard against ungodly culture, be salt and light without compromising, stand in your authority quietly but firmly. Remember: Daniel thrived in Babylon. You can thrive where God has placed you.

Q4: "How do I know if a job opportunity is from God or just a good offer?"

A: Ask these 5 questions:

1. Does this align with my God-given assignment?
2. Do I have peace about it (not just excitement)?
3. Does this increase or decrease my Kingdom impact?
4. Am I being led by the Spirit or by money/status/fear?
5. What is God saying when I ask Him directly?

If you don't have clarity, WAIT. God's opportunities don't have expiration dates.

Q5: "What's the difference between marketplace ministry and 'just being a good Christian at work'?"

A: GREAT question. Here's the difference:

"Good Christian at work":

- You go to work, do your job well, try to be nice
- You keep your faith mostly private
- You hope your actions reflect Christ
- You're passive—just trying not to sin

"Marketplace minister":

- You see your job as your MINISTRY ASSIGNMENT
- You operate with Kingdom AUTHORITY
- You actively guard spiritual gates (Vigilance)
- You hear God's voice for strategic decisions (Alignment)
- You decree Kingdom outcomes prophetically (Victory)
- You're ACTIVE—intentionally advancing God's Kingdom through your work

Both are good. Marketplace ministry is GREATER.

A Prophetic Word for Marketplace Ministers
